

**Terms of usage Rope Park Pradaschier**

- All the users of the rope park have to read the terms of usage before entering the park. All users must confirm the understanding of the terms with their signature.  
For less than 14 years olds the responsible adult person has to explain the terms to the children and confirm with his or her signature.
- The usage of the rope park bears certain risks and is at the users own risk.
- Insurance is the responsibility of the user himself.
- The park is open for children after their 10th birthday, who does not suffer of an illness or a psychological or physical handicap, which could be a danger for him or herself, or another person.  
Children before their 14th birthday have to be accompanied by an adult person.  
The usage of the park is not allowed under the influence of drugs, alcohol or medication which influences the reflexes.
- Equipment which can be of danger to the user or any other person in the park (jewelry, mobile phones, cameras etc.) is not allowed. Long hair and wide clothes are to secure. Clothing has to be sporty, and shoes should be of the gym or hiking type.
- It is mandatory to join the theoretical and practical instruction before entering the park. If there are any doubts of understanding do not hesitate to clear it with the instructor. It is mandatory to follow all instructions and decisions of the personnel. For infringements with instructions or rules users of the rope park can be banned. In case of infringements with rules or instructions Pradaschier AG will decline any liability.
- The rented equipment (helmet, harness, etc.) has to be used according to the instructions / rules and has to be returned without being asked after expiry of the time limit (max. 2 hours). Any damage to the equipment has to be notified to the personnel.
- If for any force majeure the park has to be closed, there is no right of refund.
- Court of jurisdiction is Churwalden.
- With the signature the user of the park confirms the understanding and acceptance of the terms of usage above.
